School Board Meeting Minutes For March 13, 2019

Call to Order - Chairperson Eric Brandon called the meeting to order at 6:35 pm.

RCCS Principal, Jerry Uhling's report was on hand for review and he informed the board that next year he would like to get back to academics and no longer have Brave Session.

HES Principal, Amanda O'Brien's report was on hand for review. Ms. Obrien was gone to a conference.

SPED Director, Parma Roe's report was on hand and she had nothing further.

Business Manager Rachel Amos report was on hand for review. Business Manager Rachel explained to Board that the legislature would be coming in at \$30,000 higher than expected. Rachel also informed the Board of the auditors and their untimeliness to our Charter school tax returns were filed late and that we were fined.

Charter School Advisory President Rachel Carter let the board know that the Charter Board is in support of the five-member Board.

Classified Staff Representative Dana Roane had nothing to report.

Student Representative Cheyenne McCart read the written report that was on hand in the packet.

HES Registar Lisa Smart submitted a report with the packet. Chronic Absenteeism was updated by Attendance/Athletic Secretary Michelle Williams talked about the goings on at RCCS. Director Carey Jones asked about the kids that are not coming to school and how to connect or contact them. Superintendent spoke about the materials that will go out to the towns public places and will have the schools bell schedule and will help us fight to get our kids back to school. It has been making a difference promotional marketing tools have been ordered.

Superintendent Jon Zwemke reported that North Bend will no longer be heading our Food Service. We will be taking it over completely by July 1st 2019. They do plan to still do the program for this summer but we will take it back over next summer. Jon asked to add an item to the agenda to take bids for a new auditor and giving the current auditors a 90-day notice. Chairman Eric Brandon proposes a five-member Board and explains to everyone his reasons. Superintendent also mentioned that we need to get the word out on why we are all for this five-member board. Superintendent is directed to file a ballot title so the voters can vote on it in the May election.
