- (3) Discussions of confidential medical or personal records
- (4) Litigation between the district and the media representative's organization
- ORS 192.660 (2) The governing body of a public body may hold an executive session: (i) To review and evaluate the employment-related performance of the chief executive officer of any public body, a public officer, employee or staff member who does not request an open hearing.

 - 1. Working on day to day needs for faculty, students and staff.
 - 2. Finished server room clean up and our vendor tested cables for us.

- 2. Fiscal Reports new condensed format
 - a. Would like to ask Jon to go out for a bond or something to build a gym at the elementary school. Possibly close the covered playground area.
 - b. We don't finish paying on the current bond until 2029. If we go out for another bond we have to pay this one off first. With the interest rates, it would not be fiscally irresponsible to do that now. It would put us in a bad situation to go out for a bond now.
 - c. Could we could look into long term planning with a grant? Supply chain right now will be very expensive. We can move forward to planning when we are closer to the bond being paid off. We would like to have a matching fund grant so part of it will be paid by the state.

G. Superintendent Report – Jon Zwemke

- 1. Calendar committee is almost finished. We will have the 23/24 calendar for the May board meeting and be able to advertise it for families.
- 2. Educator Job Fair in Portland, our principals attended this week. It is a huge conference usually, but this year the attendance was down to one third of the number they have had in the past. There were very few candidates. We are in a crisis of education. It is very disheartening for the future of teaching staff.
 - a. Sub pool is very shallow. Subs are quitting districts because they don't like the jobs they are being asked to do.
 - b. Educators are leaving the field because the requirements for the job has changed so much and they are just worn out and we are going to lose more if we don't provide the tools, time and support they need to succeed in their daily responsibilities.
 - c. Do we help pay for education for emergency teacher licenses? We have options in our union contract to help pay for school. There are lots of different ways to bring teachers up to license standards.

- 1. Jon would like to thank the ARESP for the labor negotiations. Some of the most efficient work, respectful communications, some of the best work he has ever seen anywhere in labor negotiations. We have maintained a good communication channel now for a few years and that let us get straight to work and it went very smoothly.
- 2. Contract changes have been submitted to you by the ARESP. Administration and ARESP would ask that the board approve the new bargaining agreement for July 1, 2023 June 30th of 2026.
- 3. Carrie Oldright made a motion to ratify the ARESP contract as presented. Bonnie Booher seconded. Vote: Yes 5, No 0. Approved.

- C. ESSER III Forklift Machine proposal wrong proposal, this one does not need board approval.
 - 1. ESSER III Tractor proposal is the correct request that needs approval.
- D. ESSER III Security Cameras for School Busses proposal
 - 1. Capital expenditure over \$5,000 must be approved by ODE.
 - 2. Why do we need security cameras on a school bus?
 - a. Behavior is happening as a bus driver is focused on the road. The driver cannot be supervising as they are driving.
 - b. We can deal with behavioral issues right away with empirical evidence.
 - c. We should consider cameras in the front and back of the bus as well.
 - d. The recording is self-contained, but when the bus returns to Wi-Fi access we can view it. Busses will be recording the entire time.

- e. The district is fronting the cost and Lewis Transportation will be responsible to maintain the equipment.
- 3. Eric Brandon made a motion to approve Action items B, C1 and D as presented with ESSER documents. Bonnie Booher seconded. Vote: Yes 5, No 0. Approved.

- B. Carrie Oldright agrees that is was great and it would be great
- C. Board line item in the budget for employee appreciation.
 - We have a set value of what we can spend on each employee. If we go over that amount,
 we would then need to tax them on it as if it were income. We don't want to go over our
 limit and we don't want to charge our employees, so Jon chooses to pay for these types of
 things out of his own pocket instead of not doing employee appreciation or having to
 charge the employees tax.
 - 2. It is difficult to deal with the specifics of perishable meal items. If something is left over, where does it go to be used. Will that be equitable?
 - 3. These kinds of expenses use to come from the Board budget but since Jon chooses to do more than one employee appreciation (item/event) per year, he pays out of his own pocket in order to provide for the staff but not cause accounting issues.
