VIII. REPORTS

A. Business Manager – Rachel Amos

- The September finance reports are not reflective of much of anything because we have not had the first payroll of the school year, so it is unencumbered. These numbers are an estimate of what we will be spending this school year. The number is going to be different once we include the encumbrances with the new payroll and throughout the rest of the year based on the numbers that we will get from the full payroll in September.
- 2. The audit starts next week so the business department is working on getting everything together for that.
- 3. Benefit insurance information was just sent over from the HR department and there will be a lot of work to do to get that updated for payroll on the 20th.
- 4. Carrie Oldright asked about the final number for school state funds. Rachel Amos responded that it is more than we budgeted for so that is a positive.
- 5. The beginning balance was a little lower than in the past, but we had expected that at the end of the last school year. We had a state school fund pay back in May. ODE was not clear on what our ADM was going to be after Covid, so we had to do the payback as we discussed in the June meeting.
- 6. Carey Jones asked a question about timber monies for this year. Rachel Amos responded that we should have some state managed timber, it will not be federal forestry, but we will get some state managed timber. She is not aware of how those were allocated or what formula was used to allocate to school districts, but we should receive it the first part of May.
- 7. Carey Jones asked about Coos Bay Wagon Road, which is the BLM one that was designed strictly for Western Douglas schools and Coos County schools. He requested that Rachel Amos try to find out what the allocation would be for Reedsport. She stated that she would try to get a number and will bring that back to the board.
- 8. The good news about funding from the state or federal timber is that they will not take that money away from our school state funding anymore as they have done in the past. The law has been reinterpreted and it was decided that those funds will no longer be deducted from our state school funds. Now those funds will be extra money so that will be beneficial to our district.

B. Superintendent Report – Jon Zwemke

- Introduce Lisa Russell as the new Elementary Principal. She has been here for a month and working on getting her family relocated so Mr. Zwemke did not request any updates from her for this meeting. However, he has been in the buildings and has seen smiling kids and engaged teachers.
- 2. 7th & 8th grade came in earlier than the rest of the Sr. High School so we could introduce them to the new house system developed at the Ron Clark Academy nationally acclaimed program. They have a demonstrated track record of success.

- a. It is an investment our students make in their education, to being at school and on time. We started the Jr. higher one day early for the school year so they could start learning about the house system and what the new expectations will be. Every year these students will grow with the house they were placed in this year.
- b. The houses are based on four characteristics and the way the students were placed in those houses was random, we spun a wheel to make it random so these students are not necessarily going to be with close friends, we wanted to mix it up and give them opportunities to be exposed to other students they may not have engaged with otherwise.
- c. The four house names are Comradery, Determination, Innovation and Empathy. House members have a community goal to earn points for those who encourage rules, peer interactions, and academic growth. The house members can be awarded points as at the end of the year bragging rights go to the house with the most points.
- d. The teachers were very excited after that first day. Some of them said it was the best first day ever.
- e. Bob Morin asked if there was a web page where they could learn more about this program. It is the Ron Clark Academy ronclarkacademy.com
- f. Carrie Oldright asked if these students progress each year and go to different houses? The students will stay with their house for the remainder of their Jr. high and high school career. New 7th graders will be added to houses every year so the team gets bigger every year and the entire school will be participating by the time these 8th graders reach their senior year.
- g. Bob Morin asked how points are awarded and distributed. The staff all have the ability to award points when they catch students doing positive things such as cleaning up after themselves in the lunchroom or being polite at assemblies. Or the houses can compete directly for something like fundraising or the collective GPA of the house. Hopefully, this will give students an incentive to be engaged in collaborative efforts.
- h. Bob Morin asked if there was a cost associated with this program. There is no cost, the teachers have taken this on because they believe it will be an enhancement to the educational experience and hopefully allow more students to be engaged and feel part of a team.
- i. Carrie Oldright asked if there was any thought of moving this into the elementary school? That has not been discussed yet but it is an option that may help with a positive transition for elementary as well.
- j. Bob Morin asked what the overall goal is for this program to be a success. The hope is that it will pay off with more engagement in school, learning soft skills and how to work collectively which will in turn improve the hard skills such as studying and

- comprehension of materials. The first two lessons were on being orderly and expectations of how to treat a sub. Those are not academic lessons, but it will improve the educational environment, maybe make the teachers' job easier which in turn allows them more time to teach those comprehensive lessons. There are 50 skills total that they will work on every year and two lessons per week is the timeline for now.
- k. The new, large gym floor will be finished tomorrow. We are excited to get our students and student athletes in the gym again. We are also working on releasing information about what we need everyone to do to keep the floor in good condition for many years. We do not want street shoes on the floor, we do not want spectators walking across the court.
- The small gym floor has a difference of almost an inch from one end to the other so
 we will have to do some leveling before that floor can be installed.
- m. The office at the Jr./Sr. high is not done yet. We ran into an obstacle of asbestos so we must take care of that before we can put the carpet down. Most of the other work is done.
- n. Contractors have been good at meeting deadlines and timely communication and updates.
- o. Teachers and students were in classrooms on the first day of school and the maintenance and custodial crews worked very hard to come behind the construction to then put back all the classroom furniture and supplies.
- p. Carrie Oldright said that is a big success for the maintenance and custodial staff and we want to thank them for their extra efforts due to summer construction. A big thank you to Michael Schoppe and his crew.
- q. The cleaning of the buildings and district warehouse has provided a lot of items for surplus, so we will be having another surplus sale very shortly.
- 3. Carrie Oldright asked if there were plans to paint an exterior wall by circle drive? We will bring this to the Maintenance Director to put that on his radar. This will be a project for after the construction is completed and everything is put back together.
- 4. Carey Jones asked if we have been able to start swimming at the elementary? Knox has found the leak in the pool and it is almost ready to reopen. In the meantime, the students have been reviewing rules and procedures for swimming so they will all be ready as soon as the pool is finished.
