Please rest assured that we have taken this decision with the utmost consideration for the well-being of our staff and the overall functioning of our school. While we recognize the impact this may have, we are committed to minimizing any adverse effects and ensuring that our students continue to receive the quality education they deserve.

In the coming weeks, we will provide you with detailed and individualized information regarding the revised school calendar, including the specific dates for the furlough days. Additionally, we will offer guidance and support to help you navigate through this transition period.

The 8 calendar dates that operations will close are recognized as:
May 20, 2024 May 21, 2024 May 22, 2024 May 23, 2024
June 10, 2024 June 11, 2024 June 12, 2024 June 13, 2024
These are the dates that no students will be in attendance. In order to keep the buildings operational during the furlough, there will be some positions staggered on the days they furlough. You will receive an individual calendar in the coming week with your actual furlough days. The intention will be to have as many people as possible furloughing the same dates. Your individual calendar will indicate which 8 days are your furlough for the year. Everyone will have the same total number of furlough days completed on or before June 30, 2024.
